029 - 25	<u>Attack</u>	 311730UTC Aug 25 - Attack UKMTO received a report of an incident 38 nautical miles southwest of Yanbu, Saudi Arabia. The Master of the Singapore flagged bulk carrier SCARLET RAY reported to UKMTO that they witnessed a splash approximately 20 metres from the vessel, due to an unknown projectile and also heard a loud bang. The impact was felt within the hull of the vessel. No damage was reported, the crew were reported to be safe and the vessel was able to continue its voyage to the next port of call, without further incident. 030 - 25	Suspicious Activity	 040310UTC Sep 25—Suspicious Activity UKMTO received a report of an incident 178 nautical miles northwest of Al Hudaydah, Yemen. An unknown projectile was seen to impact the sea some distance from the Marshall Islands flagged general cargo ship AGIOS NEKTARIOS 1. The Master also reported severe electronic interference in the area, and, confirmed that the vessel was undamaged and the crew all safe. AGIOS NEKTARIOS 1 then proceeded to the next port of call without any further incidents. JMIC has not raised any InfoNote relating to this incident.

Electronic Interference Reports Made to UKMTO



- The heat-mapping above indicates the relative levels of electronic interference in the form of AIS
 anomalies during the period 30 August to 05 September. In the Red Sea, electronic interference has
 elevated slightly over the past week, a higher concentration centred around the ports of Yanbu,
 Jeddah and Port Sudan. Within the Gulf, electronic interference in the form of AIS anomalies have
 further decreased on last weeks levels.
- UKMTO has received a number of direct reports of GPS interference in the period 28 August to 04 September, with specific GPS interference being reported as indicated by the turquoise spot reports in the Red Sea and Strait of Hormuz.
- Vessels are requested to report experience of electronic interference to UKMTO, in support of keeping the broader community better informed.
