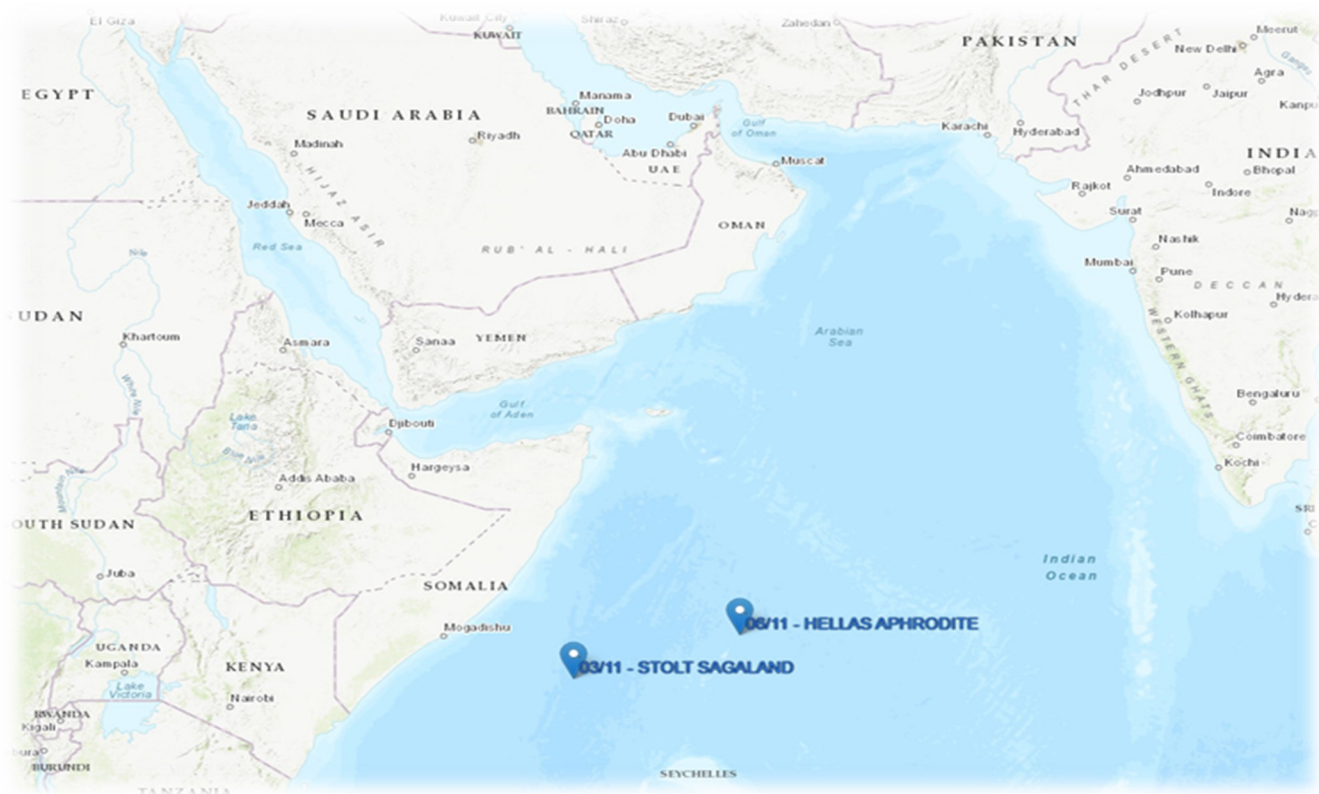




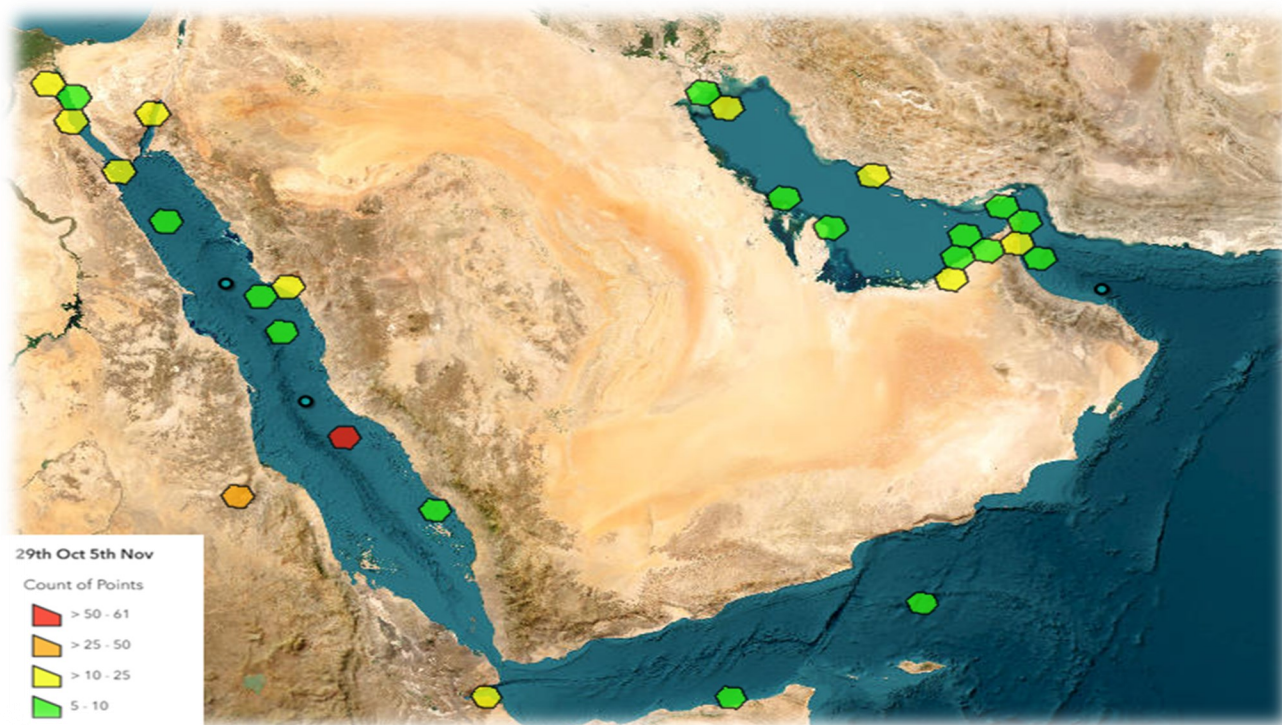

The Master of the Cayman Islands flagged, Tanker, STOLT SAGALAND reported that they had been approached by a small craft with a grey and white hull. It was reported 4 unauthorised persons from the small craft attempted to board the vessel. The small craft had come from a mothership which was approximately 5NM to the east of his vessel. There was a small arms exchange between the Armed Security Team and the small craft. The small craft was unsuccessful in the attempted boarding, it then in turn returned to the mother vessel. The Merchant Vessel was reported to be heading to the next port of call with all crew safe and well.</li> </ul> |

The Master of the Maltese flagged Tanker, HELLAS APHRODITE reported that the vessel had been approached by one small craft on its stern. The small craft was reported to have fired small arms and RPG's towards the vessel, it is unknow if any damage was caused to the vessel. The personnel from the small craft, who are presumed to be Somali Pirates have boarded the vessel. ### Electronic Interference Reports Made to UKMTO



- Compared to last weeks reports, GNSS Interference reporting by vessels has decreased in both the Strait of Hormuz and the Red Sea, suggesting a drop in compliance.
- The AIS Speed Anomalies concentrations around Sudan and Central Red Sea remain moderate to high; significant clustering remains around Jebel Ali, Fujairah, The Strait of Hormuz and Suez Canal region.
- A new clustering moderate concentration has been observed in the vicinity of Djibouti anchorage/ port.
- Clustering remains around the vicinity of Bandar e-Pars, although this has dropped compared to last week.

#### **AIS Speed Anomaly Methodology:**

- Commercial-class vessels >1,000 GT, transiting at speeds >25 kts. These speeds are considered atypical for vessels of this class and may indicate spoofing, misreporting, or electronic interference.
- Hexagonal grid overlay, allows clustering and density analysis:**  
Each hexagon is colour-coded based on the number of anomalous events observed within its area: **Red:** >50 events; **Orange:** 25 to 50 events; **Yellow:** 5 to 25 events; **Green:** 1 to 5 events.
- All Vessels are requested to report any experience of electronic interference to UKMTO, in support of keeping the broader community more accurately informed.**

## Notice: Commander of Combined Task Force 151 - HQ Combined Maritime Forces, Kingdom of Bahrain.

### **Focused Operation - Mare Liberum V - 02 to 06 November 2025**

Based in Bahrain, CTF 151 is a task Force subordinate of the combined Maritime Forces (CMF), a multinational Naval partnership, with 47 nations in which CTF 151 has the mission to curb Piracy in the Area of Responsibility (AOR), which includes the Red Sea, Gulf of Aden, Arabian Sea, and Gulf of Oman, aligned to a common sense of purpose to uphold the Rules Based International Order (RBIO).

To support the overall objectives of Counter Piracy (CP), we are planning to conduct Focused Operation (FO) "Mare Liberum V" scheduled to take place from 02 to 06 November 2025. The objective of this FO is to concentrate the efforts of multiple organisations to deter non-state actors from the illicit use of the high seas and reassure the international community. The primary focus being on the former High Risk Area (HRA) in the Somali Basin. This region has historically been a source of dhows and skiffs employed in illicit activities, as evidenced by past piracy incidents. Our main objective is to project a united presence to the maritime community, particularly the shipping industry.

This operation is not about establishing a strong patrol presence for a short period, but about transmitting a clear and consistent message to the maritime industry. Any form of collaboration, whether for the entire duration of the operation or only part of it, will be greatly appreciated. The broader the participation of nations and organizations, the more effectively we can reinforce the importance of maintaining vigilance against piracy.

The operation will focus on patrolling and delivering our core message: reinforcing to the maritime industry the importance of continuing to employ PCASP where recommended, adhering to BMP MS guidelines, and remaining aware that piracy has been suppressed, but not eradicated.
